Doors open for exhibitors **1-hour** prior to show Saturday and Sunday.
- SHOW OFFICE ► Located at Show Entrance. Open from 9:00 am on Thursday, January 31<sup>st</sup> to 4:00 pm and during show hours above.
- EXHIBITORS BADGES ► Badges can be picked up at the show office after 9:00 am on Thursday, January 31<sup>st</sup>.
- MOVE IN ► Thursday January 30<sup>th</sup> 9:00 am to 9:00 pm  
Friday January 31<sup>st</sup> 9:00 am to Noon (**No Dollies or Trolleys. Carry-in Only**)
- MOVE OUT ► Sunday February 2<sup>nd</sup> 4:15 pm to 11:00 pm  
No exhibitors may commence to dismantle, pack, or remove any part of their exhibit prior to **4:15 pm on closing day.**
- PAYMENT OF ACCOUNTS ► Exhibit space must be paid in full by **December 31, 2024.** Show management reserves the right to refuse entry to any exhibitor whose account has not been **PAID IN FULL.**
- LATECOMERS, NO SHOWS ► You must make an appearance before **7:00 pm Thursday, January 30<sup>th</sup>** or your space may be resold or reassigned by Show Management without any obligation.
- SIGNS ► Must be professionally made. No signs may be higher than your drapes without Show Management approval.
